ABSTRACT

Tamil Nadu Transparency in Tenders Act, 1998 (Tamil Nadu Act 43 of 1998) — Notification under section 16(f) of the Act — Orders notifying the Tamil Nadu Urban Infrastructure Financial Services Limited (TNUIFSL) as optional consultancy providing / procuring Agency under sub-section (f) of Section 16 of the Tamil Nadu Transparency in Tenders Act, 1998 — Issued.

ORDER:

Urban Infrastructure Financial Services Limited has stated that the various Government Departments and Institutions are requesting TNUIFSL for consultancy services, from time to time. The Government Departments, Public Sector Undertakings of the Government, Statutory Boards formed by the Government, Local Bodies in the State, Co-operative institutions in the State, Universities, Societies formed by the Government etc., have to adhere to the provisions of the Tamil Nadu Transparency in Tenders Act, 1998 (the Act) and the Tamil Nadu Transparency in Tenders Rules, 2000, amended from time to time, for procurement. As per Section 16 (f) of the Act, the provision of Section 9 and 10 of the Act shall not apply to procurement made from certain organizations, as may be notified by the Government.

- 2. The Managing Director and Chief Executive Officer, TNUFISL has also stated that considering the requirement of various Government Departments and institutions, expertise available in TNUIFSL and to save time in tendering and procurement of advisory and managerial services which are unique and innovative in nature, the Government may consider TNUIFSL as an optional consultancy providing / procuring agency under sub-section (f) of Section 16 of the Act and prescribe the following norms for availing the services of TNUIFSL by the Procuring Entities:
 - a) Nature of services: Advisory and managerial services in respect of fund management, resource mobilization, corporate governance, project development and feasibility study, detailed project report including detailed design, environmental and social assessment, economic assessment, project appraisal, tendering, bid-process management and transaction advisory, contract documents and other procurement related services, public-private partnership, project structuring, project implementation, supervision, monitoring and management, impact assessment studies and other related services in formulating,



developing and implementing urban infrastructure projects and other service which are unique and innovative in nature.

- b) Procuring Entities: Government Departments, Public Sector Undertakings of the Government, Statutory Boards formed by the Government, Local Bodies in the State, Co-operative institutions in the State, Universities, Societies formed by the Government and other similar institutions of the Government.
- c) Procurement procedure: TNUIFSL shall adhere to the provisions of the Tamil Nadu Transparency in Tenders Act, 1998 and the Tamil Nadu Transparency in Tenders Rules, 2000, amended from time to time, for procurement of external consultants for specific assignment.
- d) Fees to TNUIFSL: (i) The advisory and managerial services which involves procurement of external consultant, an amount not exceeding 5% of the consultancy contract value of the external consultant, shall be charged as fees (plus service tax applicable) by TNUIFSL and
- (ii) In the case of own consultancy assignment, fee will be decided by TNUIFSL, on case to case basis, based on the scope of the services, deliverables and execution period and requirement of manpower for the proposed services.
- 3. The Government have carefully examined the proposal of the MD& Chief Executive Officer, Tamil Nadu Urban Infrastructure Financial Services Limited and they accept the proposals to notify the Tamil Nadu Urban Infrastructure Financial Services Limited as optional consultancy providing / procuring Agency under clause (f) of Section 16 of Tamil Nadu Transparency Tenders Act, 1998 subject to the condition that in each case Government will fix the consultancy fee, wherein Tamil Nadu Urban Infrastructure Financial Services Limited itself carries out the Consultancy and service charges in case external consultancy is procured by Tamil Nadu Urban Infrastructure Financial Services Limited
- 4... Accordingly, the Government orders that the Tamil Nadu Urban Infrastructure Financial Services Limited may be notified as optional consultancy providing / procuring Agency under sub-section (f) of Section 16 of the Tamil Nadu Transparency in Tenders Act, 1998.
